 - (A) Buyer failed to observe the recommendations for the treatment, servicing and maintenance of the vehicle (eg. Owner's manual or service schedule suggested by Volkswagen, importer and dealer), or
 - (B) The vehicle has been improperly treated or overused, for example in motorsport competitions, or
 - (C) Parts have been fitted to the vehicle, the use of which or the way been altered was not approved by Volkswagen.
 - *The consultation of Volkswagen shall be final and conclusive.
- 3. Volkswagen, importer and dealer are free from any obligation of time, money, safety of drivers, passengers or other road users, or to reimburse the Passenger Car owner for Repair Services or Maintenance Services conducted at a Non-Authorized Repair Centre which would have been provided for free under the Standard Warranty or a Complimentary Extended Warranty.
